ALL TEMPORARY SIGNS ARE SUBJECT TO THE FOLLOWING CONDITIONS:

Such signs shall not exceed five (5) FEET in height and thirty-two (32) SQUARE FEET per side on a two –sided sign.

The body of the sign shall be constructed so that an approved durable material will enclose any trailer portion or supports such that the wheel or leg parts will not protrude or be exposed.

Such signs will not be illuminated in any way

Such signs shall not be erected or displayed more than a cumulative total of SIXTY (60) days in any calendar year, nor more than THIRTY (30) consecutive days.

Banner type temporary signs shall be attached flush against a secure surface such as a fence or wall.

Pennant flags may be erected for a period not to exceed TEN (10) days, commencing with the initial opening of a business or organization. They will be allowed for the initial opening only. A temporary sign permit is required.

Signs must be located on private property unless otherwise authorized by the City.

Signs cannot exhibit any parts which move in any manner, whether by air or wind currents, electrical or mechanical activation, or by any other means.

Signs cannot be located or construed as to constitute, in the sole judgment of the City, a hazard to pedestrian and/or vehicular traffic.

The removal of the sign's letters does not constitute the removal of the sign. The entire sign structure shall be removed by the permit expiration date.
