



## I-69 International Trade Corridor Next Michigan Development Corporation

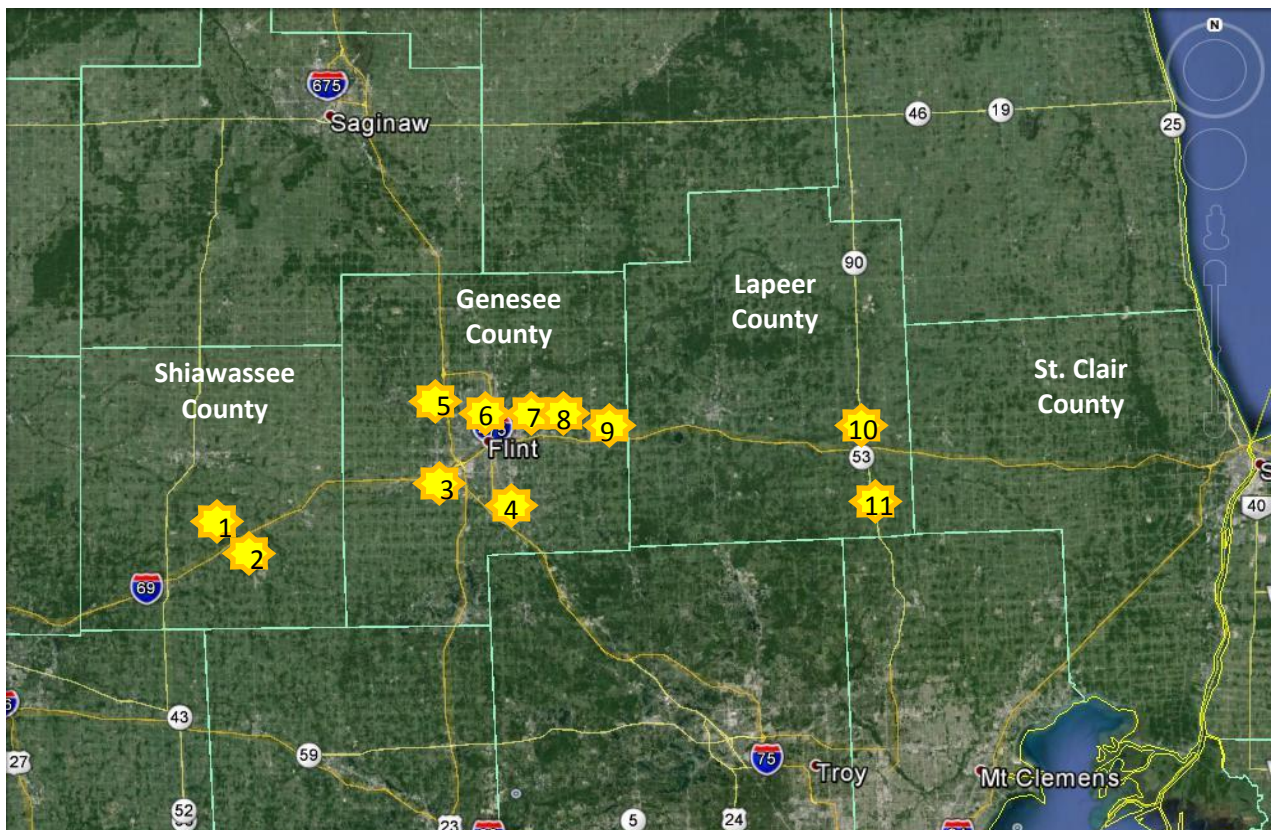
### Renaissance Zone Marketing Districts

**Zoned. Incentivized. Committed Local Partners.**

The I-69 International Trade Corridor Next Michigan Development Corporation (NMDC) is a regional municipal partnership comprised of 36 local and county governments. This group has designated 11 Renaissance Zone Marketing Districts that, pending approval from local and state authorities, may provide tax-free status for new job creation and investment projects.

In order to qualify for consideration for tax-free status, projects must involve a business that meets criteria including the following: 1) uses at least two modes of transportation to move its incoming materials and/or outgoing products; and 2) undertakes a project that creates 50 new jobs in a two year period.

As indicated in the aerial below, these districts are located in three of the four counties of the I-69 NMDC – Shiawassee, Genesee, and Lapeer Counties. The 11 areas are highlighted in the following map and table.
